We will survey the three routes to the center of the SAI (Formulas A, B, and C) and conquer obstacles including household size, the employment expense allowance, and the mythical asset protection allowance. Adjusting to Our New Normal - Tayler Kreutter

The ever changing federal regulations have created significant challenges and stress for all of us. Embracing change and adaptability has become essential. In this presentation we'll cover:

- Change during crises, and how it disrupts our ability to process information
- Understanding the toll anxiety and stress take
- · Adapting to change and being flexible enough to continue to develop and adapt
- How to transition through change

Through this session, we'll lean into the vulnerability and remind ourselves that our adrenaline cannot fuel us through a crisis that lasts for six weeks, or longer. Our goal is to have you walk away with a road map to better understand how you're feeling, find your footing, and learn how-tos on settling into a new normal; whatever that may look like next.

Marie Johnson, Director of Student Financial Services, University of Vermont

Marie Johnson serves as the Director of Student Financial Services at the University of Vermont. In her role, she oversees the administration of financial aid, bursar operations, scholarship management, and student employment, ensuring that students have access to the resources they need to succeed.

Marie holds a Bachelor's degree in Business Administration and a Master's in Public Administration, both earned from the University of Vermont. With over 30 years of experience in higher education finance, she has developed a deep understanding of student aid and receivables, demonstrating a strong commitment to serving the needs of students and families.

Throughout her career, Marie has been actively involved in professional associations, including the Vermont Association of Student Financial Aid Administrators (VASFAA), the Eastern Association of Student Financial Aid Administrators (EASFAA), and the National Association of Student Financial Aid Administrators (NASFAA). She has held various leadership roles within VASFAA and EASFAA, including as President of both associations and as a NASFAA Board member.



Ryan Dulude, Director of Financial Aid, Community College of Vermont

Ryan Dulude is the Director of Financial Aid at the Community College of Vermont, overseeing all financial aid functions across 12 academic locations in Vermont. He holds a B.A. in Journalism and Mass Communications from Saint Michael's College, and a Master of Education in Higher Education Administration from Northeastern University. Ryan has worked in financial aid for 17 years, first as a counselor at Vermont Student Assistance Corporation (VSAC) and, since 2011, at CCV. He is a past president of VASFAA and served two stints on EASFAA Council. He has served as a member of several state, regional, and national committees, including as a past chair of the EASFAA Federal Relations Committee and current chair of the VASFAA Government Relations Committee. He is a past recipient of VASFAA's Special Recognition Award and most recently became a Certified Financial Aid Administrator. Ryan's volunteer work includes serving as a gubernatorial appointee on the VSAC Board of Directors, founding board member of the Early Learning Center in Colchester, and as a youth baseball coach.

Greg Davis, Executive Director of Student Financial Services at Saint Michael's College, has been working in higher education for almost 25 years. Although the majority of that time has been in financial aid roles, his position at Saint Michael's oversees the financial aid and student account roles, which has brought him back to where it all began in a way as an Assistant Bursar at a college in NY (but at least there are no individual paper loan checks for students to sign). Greg has volunteered in a number of roles at the state and regional level, and is a past-president of VASFAA. Although thinking that the move to Direct Loans and then the move of the FAFSA to October 1st would be the biggest changes he'd experience in this field, the "FAFSA Fiasco of 2024" certainly exceeds both of those. When not wondering what the Department of Education might have in store for us next, Greg spends his free time in the Champlain Islands with his wife and two dogs (and sometimes his son, who is a rising Greg Davis, Executive Director senior at Washington & Jefferson College in PA).

Tayler Kreutter, Executive Director of Student Financial Services, Mount Holyoke College

Tayler is the Executive Director of Student Financial Services at Mount Holyoke College where she oversees financial aid, student accounts, and student employment. Tayler earned her Bachelors in Organizational and Interpersonal Communication from SUNY Brockport and Masters Degree in Higher Education Administration from the University of Rochester. She served as a Senior Associate Director at the University of Rochester and most recently as the Executive Director of Student Financial Services at Roberts Wesleyan University in Rochester, NY before relocating to Western Massachusetts two years ago.



Kristi Jovell, Assistant Vice President of Student Financial Services and Enrollment, Middlebury College

Kristi Jovell is Director of Student Financial Services Operations and Communications at Middlebury College. Prior to this role, she served as Assistant Vice President of Enrollment Management at Champlain College. Kristi is an EASFAA Past President and will begin her term as NASFAA National Chair Elect on July 1. Throughout her career, Kristi has been an active leader and participant in professional association activities at the state, regional, and national levels. Kristi earned her FAAC designation as a Certified Financial Aid Administrator from NASFAA and earned her bachelor's degree in business administration/management and master's degree in adult education from Elmira College.



Matthew DeSorgher, Sr. Associate Director of Customer Service, University of Vermont

Matt's financial aid career began at VSAC in 2003 where he worked as a loan counselor and financial aid advisor. In 2007, Matt moved to the University of Vermont where he worked for seven years as both a financial aid counselor and Assistant Director for Compliance. From 2014 through 2019 Matt worked in the Student Financial Services office at Saint Michael's College as Associate Director and Director. Matt returned to UVM in 2019 where he now serves as Associate Director of Student Financial Services.
